注意事項 Important notice:

- 1) 客戶所持有之儲蓄戶口/生息專「加」戶口(澳門幣/港幣)或商業外幣寶戶口(澳門幣/港幣),若當日結餘少於澳門幣/港幣貳仟伍佰圓,當日將不獲派發利息。
- 2) 客戶持有之儲蓄戶口/生息專「加」戶口(澳門幣/港幣),由開戶後第七個月起計算,若每月平均結餘少於澳門幣/港幣伍佰圓,本行每月將收取不時釐定的最低結餘費用。若客戶持有本行之定期存款、信用卡、貸款或任何保險產品,則可獲豁免收取該費用。
- 1) If the daily balance of Savings Account/Savings+ Account (MOP/HKD/USD) or Multicurrency Account (MOP/HKD) is below MOP/HKD2,500, there will be no interest payment.
- 2) If the monthly average balance of Savings Account/ Savings+ Account (MOP/HKD/USD) is below MOP/HKD500, calculated from the beginning of the 7th month of account opening, a low balance charge defined from time to time will be levied. This charge will be waived for customers maintaining Time Deposit, Credit Card, Loan Account or any insurance product at our bank.
