## Franklin Templeton Investment Funds (the "Company") Reclassification of Class A (Mdis) USD of Templeton Global Equity Income Fund (to be renamed Templeton Global Leaders Fund with effect from 26 June 2025) (the "Fund") into Class A (Mdis-Plus) USD

This letter is intended for investors who hold shares of the Company via an account with (i) Franklin Templeton Investments (Asia) Limited (the "**Hong Kong Representative**") or (ii) a duly authorized intermediary for the Hong Kong market (collectively, "**Investors**").

Unless otherwise specified herein, capitalized terms used in this letter shall have the meanings assigned to such terms in the Explanatory Memorandum of the Company dated April 2025, as amended from time to time (the "**Explanatory Memorandum**").

We would like to inform you that the Board of Directors has decided to modify the characteristics of distribution and the denomination of the existing Class A (Mdis) USD of the Fund into Class A (Mdis-Plus) USD (the "**Class**") effective 28 July 2025 (the "**Effective Date**"). The affected Class is listed below for your reference.

#### Why are we making this change?

We have recently amended the investment objective and policy of the Fund to make it a nonincome focused equity fund. The reclassification of the above Class into "Plus" class is addressing investors need to keep receiving a competitive level of income. "Plus" classes are distribution share classes designed to offer, under normal market conditions, dividend distribution at a pre-determined annual percentage of the Net Asset Value per Share that is not linked to income or capital gains, as more fully described in the Explanatory Memorandum. The distribution frequency, as well as the latest dividend yield of the Class will be available on

the Hong Kong Representative's website at <u>www.franklintempleton.com.hk</u><sup>2</sup> or upon request from the Hong Kong Representative.

#### What you need to do?

You do not need to do anything. On the Effective Date, Class A (Mdis) USD will be renamed to Class A (Mdis-Plus) USD as described above and you will be able to continue to invest in the Class under the same terms as previously.

The above changes will have no impact on your investments, the features (including the investment objective and policy) and risks applicable to the Fund, the operation and/or manner in which the Fund is being managed, the Class identifiers (e.g., ISIN, SEDOL) and the fee level or cost in managing the Fund. It is not expected that the above changes will materially prejudice the rights or interests of existing shareholders of Class A (Mdis) USD.

The costs and/or expenses (including the cost of publishing this letter) associated with the above changes are estimated to be approximately HKD 25,000 and will be borne by the Fund.
